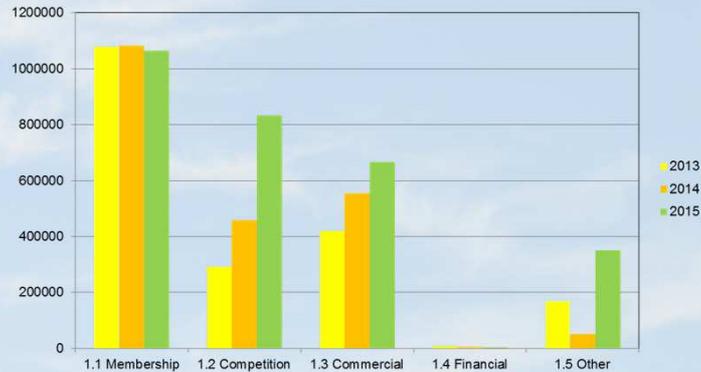

CIMA – Judging System for Competitions

- To bring CIMA sanctioned event scoring systems out of the age of paper based forms.
- For tasks which occur on the airfield, especially in Paragliders, and in the new Slalom Championships, a complete competition format which happens only on the airfield.
- Main Goal: The ability to produce statistics as the competition is being flown (eg split times) and produce scores the moment a pilot crosses the finishing line.
- PROPOSAL: A software solution, which can be installed on commonly available hand-held devices, is designed to capture the required data, and transmit it to the scoring centre.
- A specification of the desired solution is described in detail on our wiki at wiki.fai.org/x/lgHk
- Investment: 10,000€

IGC – Sailplane Racing Portal and Ranking List

- Sailplane Racing Portal
 - Website development cost to provide universal platform for all contest organizers and media
- Ranking List
 - Costs to update and refresh the existing Ranking List website
 - develop and incorporate On-Line payment system for RL events
 - need to replace long-time volunteer with a professional administrator of the RL Website
- Investment of 26,000€ in 2014 and 2015

CIA – Subsidy Hydrogen Filling Equipment Gas Balloons

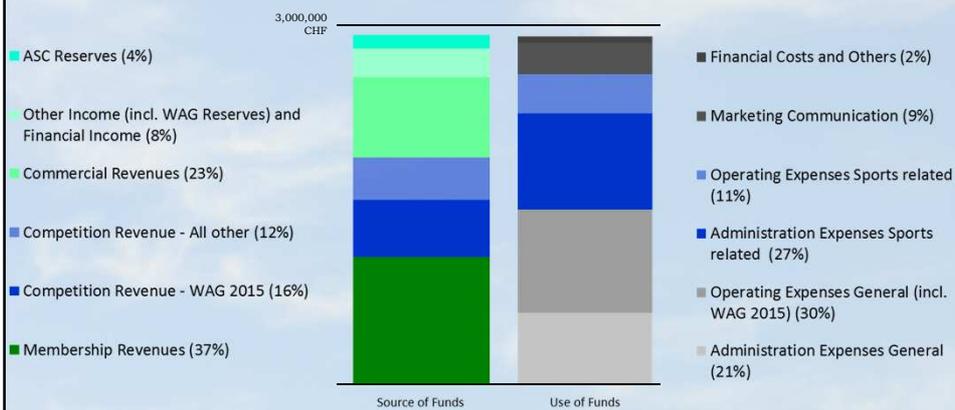
- Every year every new gas balloon event organizer faces the same problem of finding special equipment for hydrogen filling.
- CIA plans to support part of that equipment as an investment for the inflation of Gas Balloons in FAI CAT 1 Gas Balloon Events. The CIA's financial contribution would be 3,100.- € or 3,800.- CHF.
- The organizers of the GB 2014 (FFA – Fédération Française de l'Aérostation) have agreed to pay the other half of the system and be responsible for the maintenance of this equipment. A system of reselling the equipment to the next organizer will be put into use, where each recipient will take care of the storage, maintenance and also re-certification of the equipment (hydrogen compatible).

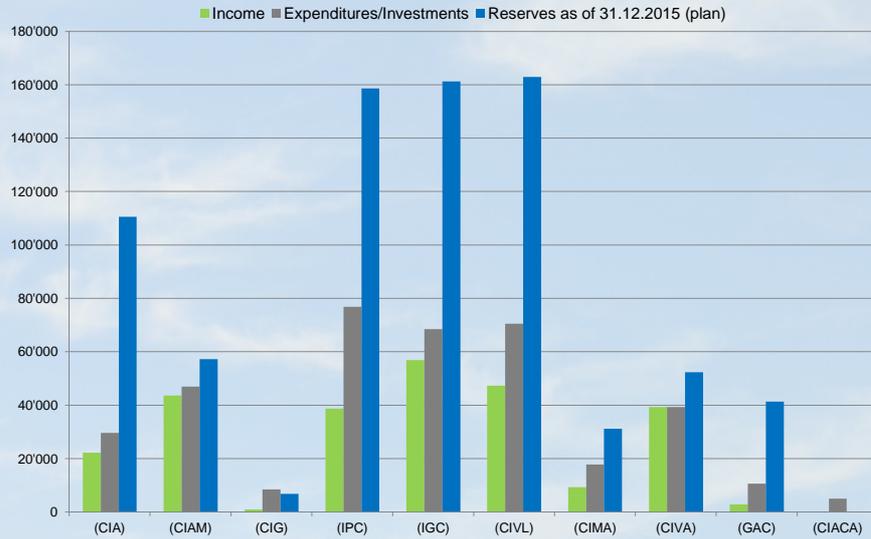
